REG. 1099/2009

- RESPONSIBILITY FOR AW AT SLAUGHTER SHIFTED FROM OFFICIAL VETERINARIAN TO FOOD BUSINESS OPERATOR

FOOD BUSINESS OPERATOR (FBO)

- RESPONSIBLE FOR THE WELFARE OF ANIMALS
- STANDARD OPERATING PROCEDURES (SOPS) – ALL PROCEDURES RELEVANT TO THE WELFARE OF ANIMALS AND REMEDIAL ACTIONS IN CASE OF DEFICIENCIES – MUST BE AVAILABLE TO OV

ROLE OF THE OV

- TRADITIONAL ROLE OF THE OFFICIAL VETERINARIAN IN A SLAUGHTERHOUSE HAS CHANGED WITH THE ENTRY INTO FORCE OF REG. 1099/2009.
- **FROM PURE INSPECTORS TO AUDITORS/INSPECTORS**

ROLE OF THE OV

- CONTROLS AND CHECKS (AUDITS) OF FBO'S SOPS AND OWN CHECKS
- DISCUSS PROBLEMS WITH ANIMAL WELFARE OFFICER TO REMEDY THE SHORTCOMINGS
- TAKE APPROPRIATE ACTIONS IN CASE OF FBO'S NON-COMPLIANCE
- FOLLOW UP FBO'S CORRECTIVE ACTIONS

AUDIT

- MEANS A SYSTEMATIC AND INDEPENDENT EXAMINATION TO DETERMINE WHETHER ACTIVITIES AND RELATED RESULTS:

1. **COMPLY** WITH PLANNED ARRANGEMENTS
2. THESE ARRANGEMENTS ARE **IMPLEMENTED EFFECTIVELY**
3. ARE **SUITABLE** TO ACHIEVE OBJECTIVES

INSPECTION

- MEANS A SYSTEMATIC AND INDEPENDENT EXAMINATION TO DETERMINE WHETHER ACTIVITIES AND RELATED RESULTS:
- MEANS THE EXAMINATION OF ANY ASPECT OF FEED, FOOD, ANIMAL HEALTH AND ANIMAL WELFARE IN ORDER TO VERIFY THAT SUCH ASPECT(S) **COMPLY** WITH LEGAL REQUIREMENTS

AUDIT VS. INSPECTION

- COMPLIANCE, EFFECTIVENESS AND SUITABILITY OF PLANNED ARRANGEMENTS (SOPS IN THIS CASE)
- VS.
- VERIFICATION OF COMPLIANCE WITH LEGAL REQUIREMENTS

AUDIT

- AUDIT IS AN OCCASIONAL EVALUATION OF THE SYSTEM (OR POSSIBLY PART OF IT) BY AN INDEPENDENT PARTY.
- COMPLIANCE, EFFECTIVENESS AND SUITABILITY OF PLANNED ARRANGEMENTS (SOPS IN THIS CASE)

AUDIT

- AN AUDIT IS THE EXAMINATION, MONITORING AND ANALYSIS OF ACTIVITIES RELATED TO A FBO'S OPERATIONS.
- A HOURLY, DAILY, WEEKLY, MONTHLY AUDIT ASSESSES THE EFFECTIVENESS OF A FBO'S SOPS.
- SOME PROCESSES MAY BE AUDITED MORE FREQUENTLY THAN OTHERS, DEPENDS ON THE RISK THEY POSE FOR THE WELFARE OF THE ANIMALS.

AUDIT

- AN AUDIT BEGINS BY AN AUDITOR ASSESSING CURRENT PROCESSES AND PROCEDURES.
- THE AUDITOR THEN ANALYSES AND COMPARES THE RESULTS TO SOP'S OBJECTIVES IN ORDER TO:
- DETERMINE WHETHER THE RESULTS **COMPLY** WITH SOPS AND OTHER FBO'S PROCEDURES AS WELL AS LEGISLATION;
- DETERMINE WHETHER THE PROCUDURES (SOPS) ARE **IMPLEMENTED EFFECTIVELY;**
- DETERMINE WHETHER PROCEDURES (SOPS) ARE **SUITABLE TO ACHIEVE THE OBJECTIVES** OF THE LEGISLATION

AUDIT

- AN AUDIT BEGINS BY AN AUDITOR ASSESSING CURRENT PROCESSES AND PROCEDURES.
- THE AUDITOR THEN ANALYSES AND COMPARES THE RESULTS TO SOP'S OBJECTIVES IN ORDER TO: DETERMINE WHETHER THE RESULTS **COMPLY** WITH SOPS AND OTHER FBO'S PROCEDURES AS WELL AS LEGISLATION;
- DETERMINE WHETHER THE PROCUDURES (SOPS) ARE **IMPLEMENTED EFFECTIVELY;**
- DETERMINE WHETHER PROCEDURES (SOPS) ARE **SUITABLE TO ACHIEVE THE OBJECTIVES** OF THE LEGISLATION
